

Log into your ELIS account



Enter Professional Development (PD)


1. *Enter Exemptions in the ELIS System* (Click on the pencil icon located in the top right corner as shown in the "Update Contact Information" instructions)

Educators are exempt from PD in the fiscal years not working 50% or more full-time equivalency in an IL public school position requiring the Professional Educator License (PEL) or the Career & Technical Educator endorsed Educator Licensure with Stipulations (ELS-CTE). This includes working in a private school, working out of state or if retired.

Please note that retired educators must complete and record the amount of professional development required for the number of fiscal years <u>worked</u> during the renewal cycle in which they retire.

Educators exempt from PD need to mark the <u>appropriate</u> employment status in the profile section. District letters will be required for exemptions not matching the **Assignment History** in ELIS. <u>It is important that the</u> <u>employment status be kept up to date by the end of every fiscal year.</u>

- 5. The lists containing the approved PD activities and verification documentation for each type of license was valid for PD completed until 12/31/2014. Aside from the exceptions below, the only verification now valid is the Evidence of Completion Form 77-21B from an IL Approved PD Provider. Lack of verification through evidence of completion form 77-21B for all other PD activities completed 01/01/2015 and after equals no credit:
 - College coursework through schools with an Illinois approved program OR Illinois community college is verified through an official transcript.
 - School Support Personnel who hold an IDFPR or applicable national licensure must submit verification of said licensure.
 - Administrator Academies do not need to be verified because these activities are entered by the provider.
- 6. The subsequent steps are for individuals due for renewal in the current fiscal year.

Renew & Pay Registration:

- 1. Individuals are unable to process until <u>April 1st of the renewal year</u>.
- 2. Submissions are automatically approved because *ELIS is now programmed to allow for the submission of PD and payment of registration in a single process.*
- 3. When you have entered enough PD to satisfy your renewal requirement **OR** you have marked yourself exempt for the entire cycle, the **Click Here To Renew** link will appear.

- 4. Follow the screen prompts in the **Renewal Wizard** to complete the process. **Select Region 56 Will ROE** on the region selection screen.
- 5. Renewal fees are currently \$50 plus processing fee by Debit or Credit Card. Licensees who are retired and qualify for benefits from an Illinois State retirement system pay no registration fees at renewal.
- 6. If you do not enter the required professional development and renew by August 31st, your license will lapse on September 1st.
- 7. Please refer to the <u>Reinstatement</u> page of ISBE's website for details on reinstating a lapsed license.

Special Alert

ISBE modified the PD entry page in ELIS to allow the educator to select a provider from a drop-down list that was pulled from the state's Entity Profile System (EPS), or manually enter the name of a provider that is not on the list when they add a new PD activity. It was recently discovered that there are entities on that list that are **NOT** Illinois Approved Professional Development Providers. ISBE is currently reviewing the list to remove the unapproved entities. They are also vetting each manual entry by educators to ensure each listed provider is truly approved to offer PD for licensure renewal. The state hopes to have a more accurate list soon. Despite what educators may see on the Professional Development Provider drop down list, individuals must follow the aforementioned information about what qualifies as PD. Let me reiterate that aside from the exceptions below, lack of verification through evidence of completion form <u>77-21B</u> for all other PD activities equals <u>no credit</u>:

- College coursework through schools with an Illinois approved program OR Illinois community college is verified through an official transcript.
- School Support Personnel who hold an IDFPR or applicable national licensure must submit verification of said licensure.
- Administrator Academies do not need to be verified because these activities are entered by the provider.
